- I. The required amount is due to him because of the Tenderer's actions in accordance with one or more of the conditions specified in Clause 11.2 of the Terms and Conditions of Tender and listing these conditions.
- II. Upon the deadline for submission of Tenders, during the validity period of the Tender, the Tenderer recalls or modifies his Tender;
- III. At the request of the Contracting Entity, the Tenderer has not corrected the arithmetic errors observed in the Tender and/or failed to explain the Tender via CVP IS electronic means.
- IV. At the request of Contracting Entity, the Tenderer - possible winner shall not submit the documents certifying its compliance with the qualification requirements specified in Annex 5 of the Terms and Conditions of Tender;
- V. The Tenderer who has been offered to conclude a Purchase Contract refuses to conclude it by CVP IS electronic means or fails to submit a copy of the security of performance of the Purchase Contract and the Civil Liability Insurance Policy of a designer as well as a list of managers as set out in the Purchase Documents.
- VI. The Tenderer does not sign the Purchase Contract or refuses to conclude it before the time fixed by the Contracting Entity under the conditions specified in the Procurement Documents.

This guarantee is neither assignable nor transferable.

This guarantee shall expire at the latest on the above expiry date. On or before that date all claims must be presented to us in writing (by registered mail, courier service or authenticated swift) in order to be taken into consideration. Upon expiry this guarantee shall be considered null and void whether returned to us for cancellation or not and any claim or statement received after expiry shall be ineffective. If the expiry date falls on a non-banking day in Finland, claims must reach us on the first banking day after such expiry date.
