

## FIRST AMENDMENT TO THE LICENCE AGREEMENT

THIS AMENDMENT OF THE LICENCE AGREEMENT is made on the date of signing the Agreement

**BETWEEN: EBSCO International, Inc.** whose registered office is at 5724 Highway 280 East, Birmingham, AL 35242, USA (the "Publisher").

**AND THE LITHUANIAN RESEARCH LIBRARY CONSORTIUM** whose registered office is at Saulėtekio Ave. 14, LT-10223, Vilnius, Lithuania (the "Licensee").

### RECITALS

**WHEREAS** the parties are willing to amend the Licence Agreement made between the Parties on 13 of November, 2024 (hereinafter referred to as the Licence Agreement);

10. This Amendment to the Licence Agreement shall enter into force upon its signing by the Parties and shall be an integral part of the Licence Agreement.

11. This Amendment shall remain in full force until the Parties fulfil their obligations under the Licence Agreement or the Licence Agreement is terminated.

12. Upon the entry into force of this Amendment to the Licence Agreement, other provisions of the Licence Agreement shall remain unchanged.
