Variation of Agreement dated 29 November 2024

1. We refer to the Agreement between (1) Emerald Publishing Limited; and (2) Lithuanian Research Library Consortium dated 29 November 2024 (**Agreement**).
2. With effect from the date of this amendment letter (**Variation Date**), the parties wish to amend the Agreement as set out in this amendment letter.
3. Expressions defined in the Agreement and used in this amendment letter have the same meaning as set out in the Agreement unless otherwise defined.
4. With effect from the Variation Date, and in consideration of their mutual obligations given under this letter (the sufficiency of which is acknowledged by each party), the parties agree to remove the following Licensed Materials from the Agreement for the following Consortium Member and for the relevant Periods as follows:

5. For the avoidance of doubt, references to Martyna Mažvydas National Library of Lithuania in Annex 2 of the Agreement shall be removed with effect from the Variation Date.
6. With effect from the Variation Date, and in consideration of their mutual obligations given under this letter (the sufficiency of which is acknowledged by each party), the parties agree that clauses 3.2 and 3.3 of "Annex 1 to the Contracts Documents" in Annex 2 - "Annexes 1 + 2 of Tender" shall be amended to state:
 - 3.2 Instalment 2 - from 1 January 2026 till 31 December 2026 - 120,929.45 EUR (VAT inclusive),
 - 3.3 Instalment 3 - from 1 January 2027 till 31 December 2027 - 126,970.90 EUR (VAT inclusive).
7. Except as set out in paragraphs 4, 5 and 6 of this amendment letter, the Agreement will continue in full force and effect.
8. To the extent of any conflict between the terms of the Agreement and this amendment letter, the terms of this amendment letter will prevail.
9. This amendment letter and any dispute or claim arising out of or in connection with it or its subject matter or formation (including non-contractual disputes or claims) shall be governed by and construed in accordance with the laws of England and the parties submit to the non-exclusive jurisdiction of the Courts of the Republic of Lithuania.
10. Please sign and return a copy of this letter to acknowledge your agreement to the variation of the Agreement.
