

**ADDENDUM To Technical Specification –
Taylor & Francis Journals License**

THIS ADDENDUM to the Terms and Conditions of Access of the Taylor & Francis Journals License dated 26.6.2024 is made on 3rd November 2025

Between:

- (1) **INFORMA UK LIMITED trading as TAYLOR & FRANCIS GROUP**, a company registered in England and Wales with company number 01072954 whose registered office is at 5 Howick Place, London, SW1P 1WG, United Kingdom and whose principal place of business is 4 Park Square, Milton Park, Abingdon, Oxfordshire, OX14 4RN, United Kingdom (the “**Publisher**”, which includes the Publisher’s administrators, assigns and successors in business, as may be appropriate); and
- (2) **THE LITHUANIAN RESEARCH LIBRARY CONSORTIUM** whose registered office is at Saulėtekio Ave 14, LT-10223 Vilnius, Lithuania (the “**Licensee**”),

each a “**Party**” and together the “**Parties**”.
