In accordance with clauses 7.6 and 15.1 of the Licence Agreement,

The Parties agreed to amend the Licence Agreement made between the Parties on 17 of November, 2023 as follows:

1. To ADD:

  - 3855,60 EUR euro including VAT, which is 0 percent (3855,60 EUR excluding VAT) in 2025
  - 4009,82 EUR euro including VAT, which is 0 percent (4009,82 EUR excluding VAT) in 2026.
- 1.2. **Vilnius Academy of Arts** as the Licenced institution for the services of subscription to the online research database **The Arts Ebook Subscription (the description is provided in Annex A)** for the Authorised Users of the LMBA Authorised Institutions from 1 January 2025 till 31 December 2026 for
  - 1674,00 EUR euro including VAT, which is 0 percent (1674.00 EUR excluding VAT) in 2025
  - 1740,96 EUR euro including VAT, which is 0 percent (1740,96 EUR excluding VAT) in 2026.
- 1.3. **Vilnius University** as the Licenced institution for the services of subscription to the online research database **Primary Sources Foundation Collection - International (Plan E) (the description is provided in Annex A)** for the Authorised Users of the LMBA Authorised Institutions from 1 January 2025 till 31 December 2026 for
  - 19470.10 EUR euro including VAT, which is 0 percent (1674.00 EUR excluding VAT) in 2025
  - 20248.90 EUR euro including VAT, which is 0 percent (1740,96 EUR excluding VAT) in 2026.

2. To REMOVE:

- 2.1. Vilnius College of Design as the Licenced institution for the services of subscription to the online research database **Vogue Archive** for the Authorised Users of the LMBA Authorised Institutions from 1 January 2025 till 31 December 2026 for
  - 2.207,82 EUR euro including VAT, which is 0 percent (2.207,82 EUR excluding VAT) in 2025
  - 2.296,13 EUR euro including VAT, which is 0 percent (2.296,13 EUR excluding VAT) in 2026
- 2.2. **Lithuanian Music and Theatre Academy** as the Licenced institution for the services of subscription to the online research database **RefWorks** for the Authorised Users of the LMBA Authorised Institutions from 1 January 2025 till 31 December 2026 for

- 1.616,36 EUR euro including VAT, which is 0 percent (1.616,36 EUR excluding VAT) in 2025  
1.681,01 EUR euro including VAT, which is 0 percent (1.681,01 EUR excluding VAT) in 2026.

2.3. **Vilnius University** as the Licenced institution for the services of subscription to the online research database **Periodicals Archive Online** for the Authorised Users of the LMBA Authorised Institutions from 1 January 2025 till 31 December 2026 for

- 17.700,07 EUR euro including VAT, which is 0 percent (17.700,07 EUR excluding VAT) in 2025  
18.408,07 EUR euro including VAT, which is 0 percent (18.408,07 EUR excluding VAT) in 2026.

3. To AMEND clause 7.2.3 into: Instalment 3 - from 1 January 2025 till 31 December 2025 – 144,659.03 (VAT inclusive).  
To AMEND clause 7.2.4 into: Instalment 4 - from 1 January 2026 till 31 December 2026 – 150,445.39 (VAT inclusive).

4. This Amendment to the License Agreement shall enter into force upon its signing by the Parties and shall be an integral part of the Licence Agreement.

5. This Amendment shall remain in full force until the Parties fulfil their obligations under the Licence Agreement or the Licence Agreement is terminated.

6. Upon the entry into force of this Amendment to the Licence Agreement, other provisions of the Licence Agreement shall remain unchanged.
