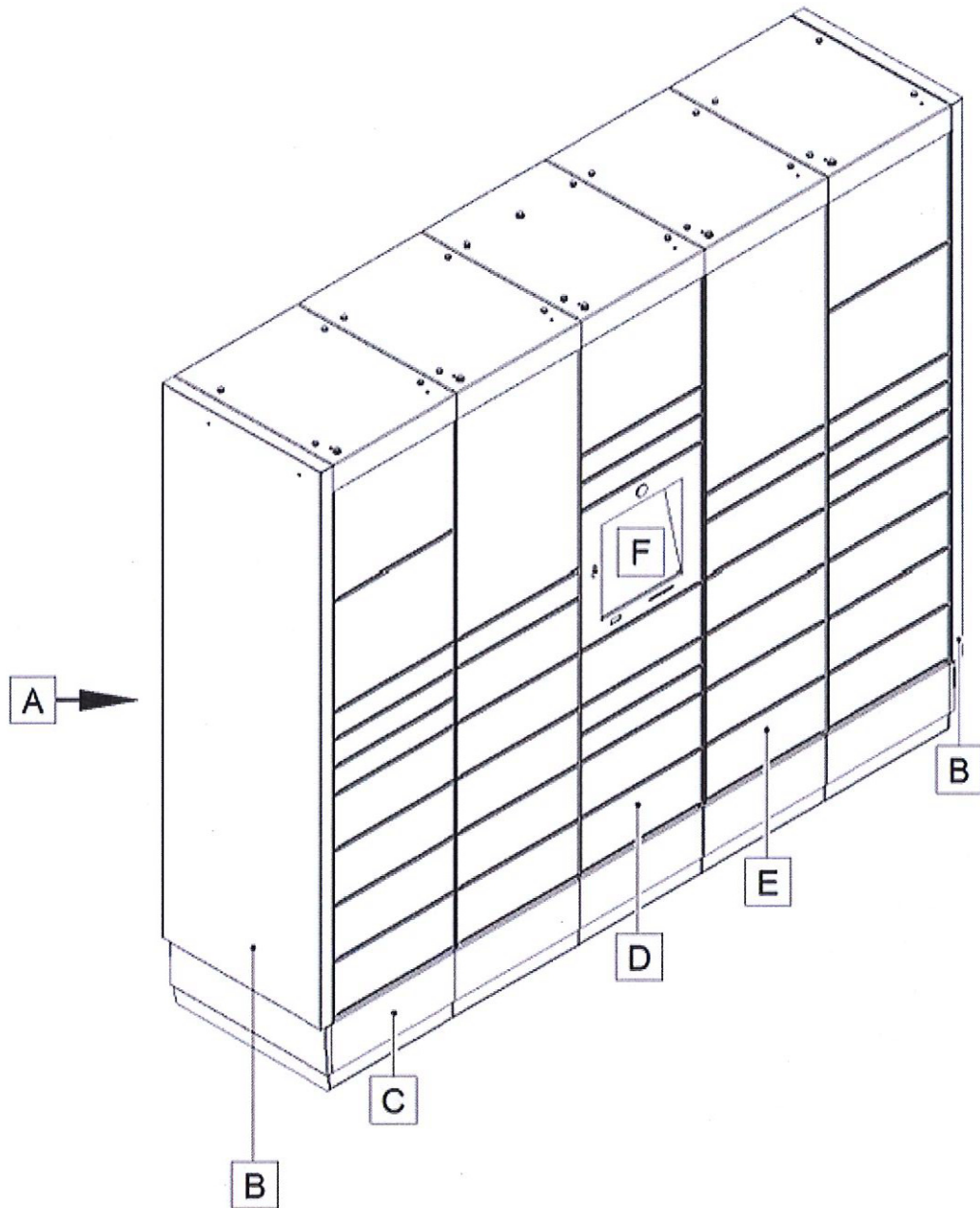

C ... FND module pedestal

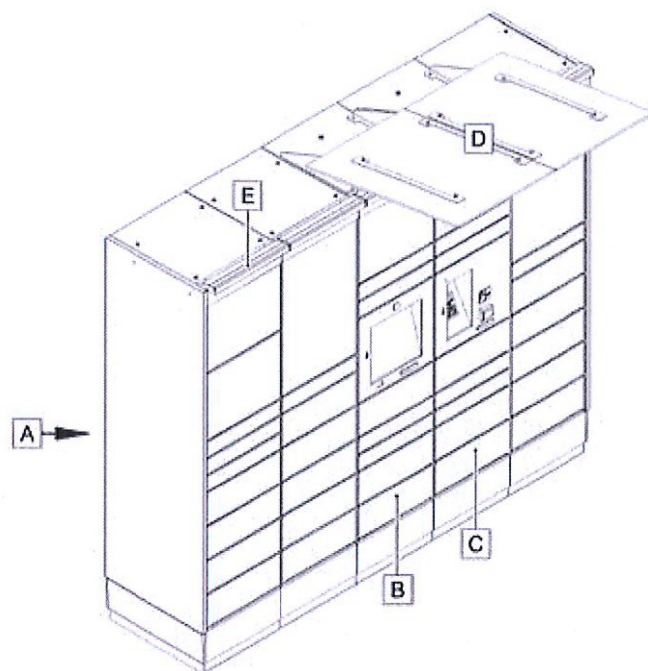
D ... CON control module

E ... MOD box module

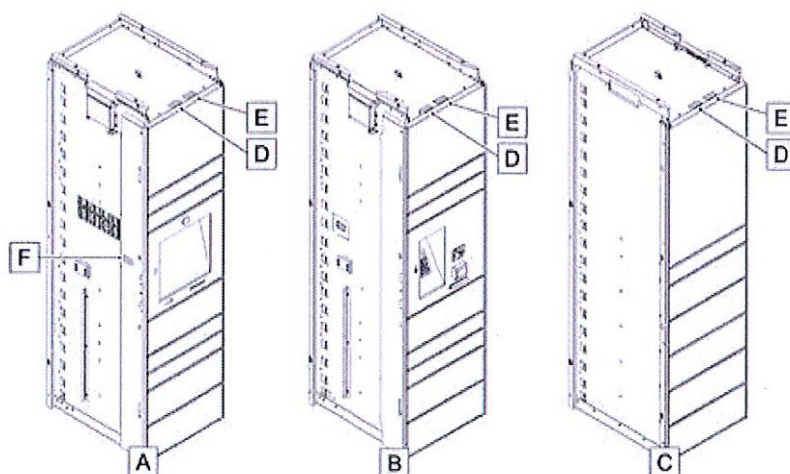
F ... Electronics compartment with operating panel
