

## CONTRACT Nr. 2022-08

2022-04-07

Telšiai Culture Center, represented by Director Linas Ulkštinas, hereinafter referred to as „CUSTOMER“ and SIA IDL EVENTS (Reg.Nr. 40103916192), hereinafter referred to as "PERFORMER" concluded the following contract:

### 1. Subject of the contract

1.1. PERFORMER fulfill a 75-90 minute musical program of QUEENtESSENCE & RIHARDS SAULE at the concert cycle "Water Music", which will take place in 2022 July 14th, in Telšiai City Amphitheater (Lithuania).

### 2. Obligations of the contracting parties

2.1. By this contract, the PERFORMER undertakes:

2.1.1. To perform a musical program at the event;

2.1.2. PERFORMER shall treat all documents and information, received from the CUSTOMER, as confidential and shall not disclose any provisions of the Agreement without prior written permission of the CUSTOMER, except when it's required to provide arrangements for Agreement.

2.2. By this contract, the CUSTOMER undertakes:

2.2.2. To provide PERFORMER with all necessary information for the proper performance of the CUSTOMER'S obligations under this Agreement;

2.2.3. To pay a fee for PERFORMERS high-quality program fulfillment.

### 3. Payment procedure

3.1. CUSTOMER undertakes responsibility to pay the PERFORMER (according to the submitted invoice) 3993,00 Eur (three thousand nine hundred and ninety three euro) by transferring it to the settlement account specified by PERFORMER: LV33HABA0551040385373, located at "Swedbank" bank.

3.2. Remuneration to PERFORMER must be paid: 50% prepayment (1996,5 Eur) and the remaining 50% (1996,5 Eur) within 10 working days after performance.

### 4. Liability of the parties



4.1. In case PERFORMER has not arrived and/or has not performed, PERFORMER has to cover the losses incurred by CUSTOMER in amount of 1996,5 Eur.

4.2. Neither of the parties takes responsibility for the total or partial non-fulfillment of this contract if this is due to force majeure circumstances.

#### **5. Amendment and cancellation of the contract**

5.1. The contract may only be replaced by a written agreement between both parties. All amendments, supplements and annexes to this agreement are valid only if they are signed by both parties.

5.2. The contract may be terminated before the deadline only if CUSTOMER and PERFORMER fully agrees on it.

#### **6. Final Provisions**

6.1. This contract shall enter into force after both parties sign it and shall remain in force until both parties fulfill their obligations under this contract.

6.2. The parties undertake responsibility not to disclose to third parties any terms of this contract, except cases provided by the law of Republic of Lithuania..

6.3. This contract is made in two copies with equal legal force - one for each country
