Confirmation of Terms & Conditions: Aesculap Technical Service Germany

Dear Sir or Madam,

we confirm the following conditions valid for the Aesculap Technical Service (ATS) in Germany:

1. Aesculap Technical Service repairs or exchanges all Aesculap products and standard surgical instruments from other manufacturers, as long as we have an equivalent in our portfolio. Our repair portfolio also includes instruments with Noir coating (e.g. scissors / bone punches with titanium aluminium nitride coating).
2. After repair of a surgical instrument, we apply a new product marking and the service code by using validated laser marking technology. The service code consists minimum of ATS + year of repair, but can also contain the month of repair, additionally (depending on the instrument type).
3. For our customers, we provide special transportation boxes on request, which can be used as safe packaging for the shipment of repair goods to ATS and back to the customer.
4. The average internal turnaround time for instrument repairs and exchange in ATS is 7 working days. The turnaround time may differ depending on incoming order volumes.
5. If an instrument is not repairable, we offer our customers to replace it directly with a new Aesculap article, if the product is available in our portfolio. If our customers don't agree to the replacement, the defective instrument will be marked with a special label, explaining the impossibility of repair and sent back unrepaired.
