Confirmation

Dear Sir or Madam,

Hereby we confirm that our Foliodrape® draping materials PROTECT, PROTECT PLUS, ECO, BTC, BTC extra-reinforced, MSC and MSC extra-reinforced were tested according to EN 13795-1:2019 and fulfill all requirements of the highest possible quality level "performance level high, critical area of a product".

The conducted tests of the barrier properties follow the EN 13795-1:2019. For this highest possible quality level, it is the test according to EN ISO 22610:2006 (Resistance to microbial penetration - wet).

Tests according to EN ISO 22612:2005 (resistance to microbial penetration - dry) are not required by EN13795-1:2019 for this highest level of quality, due to the fact that it can be assumed that the requirements of EN ISO 22610:2006 (resistance to microbial penetration - wet) exceeding those of EN ISO 22612:2005.

As we bring our products sterilized on the market a test for microbial cleanliness (EN 11737-1) is not necessary (see chapter 5.2 of EN 13795-1:2019):

"5.2 testing shall be performed on the finished product. If the product is to be used after sterilization, testing shall be performed on products after sterilisation with the exception of microbial cleanliness". We confirm that our products are sterile in accordance with EN 556.

Furthermore, we confirm that the total weight (mass per unit area) mentioned in our Technical data sheets is measured according to EN ISO 29073-1.
