

Sponsorship Agreement Tirana Slush'D 2024

This agreement is made today **23/10/2024** between the parties:

B Limitless (sh.p.k) registered with the National Business Center on 24/04/2023 with Nipt number M31624014K and located at Blv Rruga Panorama, nr.4 Tirana, represented by [redacted] in her capacity as the company's administrator.
(hereinafter referred to as the "Beneficiary")

Public enterprise Invest Lithuania, legal entity Reg. No 124013427, registered address Upės Str. 23-1, 08128 Vilnius, represented by [redacted] acting under attorney.

(hereinafter referred to as the "Sponsor")

The parties agree to the following terms and conditions:

Article 1 Object

1. The Sponsor will provide sponsorship for the Tirana Slush'D 2024 event, which will take place at "Piramida e Tiranës" on October 24-25, 2024, organized by the Beneficiary.
2. The Sponsor will provide its sponsorship in the amount of 4000 (four thousand) euros.
3. The Sponsor may provide an additional sponsorship in the amount of 1,000 (one thousand) euros if they wish to display their banners at the event.

Article 2 Obligations of the Beneficiary

1. The Beneficiary has the obligation to promote the sponsor through:
 - logo on marketing materials
 - logo on the event website
 - logo on main stage backdrop
 - press releases and media
 - 3 tickets
 - attendee list access
 - social media posts
 - opportunity to hold a workshop, 1 hour, dedicated room and staff
 - optional, placement of banners with an additional fee as specified in Article 4
2. The Beneficiary has the right to benefit from the sponsorship and is obliged to use it solely for the purpose of carrying out the event specified in this agreement.

Article 3
Obligations of the Sponsor

1. The Sponsor is obliged to financially support the Beneficiary for the realization of the Tirana Slush'D 2024 event.
2. The Sponsor must fulfill its financial obligations in accordance with the provisions of Article 4 of this agreement.

Article 4
Fees and Payments

1. For the purpose of sponsoring the Tirana Slush'D 2024 event and promoting the Sponsor, the Sponsor will sponsor the Beneficiary in the amount of 4000 (four thousand) euros.
2. Placement of banners will have an additional fee of 1000 (one thousand) euros.
3. An invoice will be issued by the Beneficiary within 15 (fifteen) days from the signing of this agreement, and payment must be made within 14 (fourteen) working days to the bank accounts of the Beneficiary specified in the invoice.

Article 5
Termination of the Agreement

1. This agreement terminates on October 25, 2024, which also represents the conclusion of the Tirana Slush'D 2024 event.
2. Neither party has the right to withdraw from this agreement unilaterally, except in cases where the parties reach a written agreement for this purpose.

Article 6
Final Provisions

1. Any amendment, addition, or complete or partial annulment of this agreement shall have no effect unless made in writing and signed by both parties.
2. Both parties shall respect the applicable Albanian legislation and shall endeavor to resolve conflicts and disputes amicably; in case of disagreement, the competent court will be the Court of First Instance Tirana.
3. This agreement comes into effect upon signature by both parties.
