THIS AMENDMENT OF THE LICENCE AGREEMENT is made on the date of signing the Agreement

RECITALS

WHEREAS the parties are willing to amend the Licence Agreement made between the Parties on 15 of November, 2023 (hereinafter referred to as the Licence Agreement);

AND WHEREAS the amendment is made according to Clause 15.1 of the Licence Agreement and Article 89 of the Law on Public Procurement of the Republic of Lithuania.
