

## CONTRACT ON TRAINING AND EXAMINATION No.

Vilnius

2023-09-27

VšĮ Statybos sektoriaus vystymo agentūra, hereinafter referred to as “the Executor”, and Budimex S.A., hereinafter referred to as “the Customer”, have concluded the Contract on the following:

### 1 SUBJECT OF THE CONTRACT

- 1.1 The Executor undertakes to provide training seminar on construction legislation of Lithuania and exam of legal knowledge according to program approved by the Minister of Environment.
- 1.2 The training seminar shall be provided on 11<sup>th</sup> October 2023, exam of legal knowledge shall be provided on 12<sup>th</sup> October 2023 in Customer's place in Warsaw (Budimex S.A., 9 Siedmiogrodzka Street, 01-204 Warsaw, Poland). The Customer undertakes to provide premises and media.
- 1.3 The training seminar shall be provided in Lithuanian. The tests for the exam of legal knowledge shall be prepared in Lithuanian. The Customer undertakes to provide interpretation.
- 1.4 The Customer undertakes to provide an expert of the Executor with transportation from Vilnius to the Services place and back and accommodation at the Customer's own expenses.

### 2 PAYMENT FOR THE SERVICES

- 2.1 The Customer shall pay the Executor for the services 4500,00 EUR (four thousand five hundred euro, 00 ct.).
- 2.2 The payment shall be made before the training seminar date according to the proforma invoice. Payer's bank's charges shall be covered by the payer.
- 2.3 The right recognition is not a subject of the contract. The Customer shall pay 120,00 EUR (one hundred euro, 00 ct) for each person according to Lithuanian right's recognition procedure terms.

### 3 FORCE MAJEURE

- 3.1 The Executor is not liable for not fulfilling terms of this Contract partly or in full scale in case of non-predictable force majeure conditions arising after signing this Contract.
- 3.2 The Executor shall be required to indemnify the Customer about arising of such conditions and both contracting parties shall review the issue on continuation or termination of this Contract within 5 working days.

### 4 FINAL PROVISIONS

- 4.1 The Contract is valid until 2023-10-13
- 4.2 The Contract is made in English in two copies having validity of original – one for each party.
