1. withdrew its Bid or part of it (subject of the order, quantity (size) of the order, offered prices, terms of delivery or payment, other conditions specified in the offer) before the expiry of the validity period of the Bid Bond, or
2. failed to provide justification for the abnormally low price, or
3. failed to provide documents confirming the lack of grounds for exclusion and meeting the qualification requirements, after its Bid being considered the most economically advantageous, or
4. refused to conclude the contract or failed to sign the contract within the deadline set by the contracting authority.

Your written and duly signed request for payment including the declaration as above must be presented to us by registered letter or courier to the address **Bank Polska Kasa Opieki Spółka Akcyjna, International Banking and Trade Finance Department, Trade Finance Office, Guarantee Team, ul. J. Conrada 37, 31-357 Kraków, Poland** through the intermediary of your bank which must confirm that the signatures appearing on the request for payment belong to the persons empowered to represent your company.

Our guarantee is valid until **15th August 2024** and it shall expire fully and automatically in the following situations:

1. if the request for payment including the declaration as above is not presented to us on or before that day,
2. if you release us from obligations provided for in the guarantee, before its expiry, in the manner provided for the request for payment,
3. when our payments made under this guarantee reach the value of the guarantee.

The total amount of this indemnity will be reduced by any payment effected hereunder.
