The parties hereby agree as follows.

1. Subject of the contract:

1.1. The Contractor agrees to deliver two concert for the Client, concert with FRÄNDER hereinafter referred to as ‘Concert’.

1.1.1. Concert date: 27-28 June 2025

1.1.2 Concert venue: Festival „Aš pasiejau vėina popa“, Telšiai (manager Rita Macijauskiene marita@gmail.com)

1.1.3. Concert duration: minimum 60 minutes + encores.

1.2. The concert is organized by Aš pasiejau vėina pop, hereinafter referred to as „Festival“.

1.3. The Contractor declares that is entitled to conclude this contract on behalf of the Concert Performers.

2. Fee and payments:

2.1. For carrying out the task of the Contract stated in 1 and for granting the license specified in 6, the Contractor is entitled to a net amount of 4600 EUR (for thousand six hundred euros).

2.2. The Client will cover any licence tax in Lithuania.

2.3. The fee stated in Section 1 shall be transferred after the Concert to the Contractor’s bank account, on the basis of the submitted invoice, within 14 days of receiving the invoice.

3.3. Travel, accommodation and technical equipment:

3. The Client agrees to provide the following:

3.1.1. Accommodation and board on the concert days in Telšiai, local transport (airport-Hotel-Festival site-airport)

3.1.2 Sound system, stage lighting and backline in accordance with the technical rider constituting Annex 1 to this Contract,

3.1.3 A proper soundcheck (at least 2 hours before the Concert) in accordance with the schedule constituting Annex 2 to this Contract.

3.2. All details related to the obligations mentioned in Section 1 shall be agreed by e-mail between a representative of the Client (marita1216@gmail.com) and a representative of the Contractor

(gabbi@frander.se).

3.3. Other obligations of the Client:

4. The Client agrees to ensure the following:

4.1. safety during the Concert,

4.2. payment of royalties to „ZAIKS“ (Society of Authors) on the basis of the list of performed music pieces provided by the Contractor,

4.3. space for the sale of Contractor's merchandise at no charge.

4.4 Other than the remuneration specified in 2 and the obligations specified in 3 and 4 Section

4.5. the Client is not required to pay any other charges or to meet any other obligations to the Contractor for his performance hereunder.

4.6. Non-performance and contractual penalties:

4.7. Should the Contractor fail to perform his contractual obligations hereunder, the Client shall have the right to rescind the contract without payment of the fee to the Contractor and apply a contractual penalty of 30 % of the fee specified in § 2.

4.8. The Parties shall not seek any financial compensation if the Contract's failure to perform caused by force majeure.

5. License:

5.1. The Contractor shall deliver to the Client promotional materials on which the Contractor has the copyright and, within his rights, consents to their publication for Festival promotion purposes.

5.2. Acting within his rights, the Contractor grants the Client licence with respect to the public performance defined in § 1 and consents to the Client's audio and video recording of 50% duration of the Concert, hereinafter referred to as the 'Recording'.

5.3. The Contractor grants the Client license to use the Recording in the following forms of exploitation:

5.3.1. recording on any media, including digital media,

5.3.2. using in a documentary presenting the Festival,

5.3.3. broadcasting selected fragments of the Recording on Client's websites,

5.3.4. using for advertising and promotional activities within the scope defined by the Client's statutes.

5.3.5. This licence is granted for the period until 31st December 2026.

5.3.6 All the rights granted hereunder may be transferred to a third party to produce the Recording referred to in Section 2, whereas the licence granted is non-exclusive.

6. Final provisions:

6.1. In case of any controversies arising over this contract, the parties will refer them to the court

having local jurisdiction over the seat of the Client.

6.2. All amendments and supplements to this Contract shall be considered null and void unless made in writing.
