**2. INFORMATION ON SUBCONTRACTORS INTENDED FOR SUBCONTRACTING OR

In such a case the Economic Entities whose capacities are being relied upon are not required to submit ESPD, their qualifications and filled in ESPD will not be verified before identifying the winning tender, and such Economic Entities will be considered as subcontractors.<sup>1</sup> It is noted that the Supplier may not rely on those Economic Entities who have not been disclosed by it.

**Together with the request for participation we provide evidence that throughout performance of the Contract we will have at our disposal the resources of the Economic Entities listed in Table No. 2.1.**
