Know all people by these presents that We Svenska Handelsbanken AB (publ), Branch Operation in Finland having our registered office at Itämerenkatu 11-13, FI-00180 Helsinki, Finland (hereinafter called "the Bank") are bound unto Public Enterprise Transport Competence Agency (TKA) (hereinafter called "the Purchaser") in the sum of EUR 3.000,00 (EUR threethousand 00/100) for which payment well and truly to be made to the said Purchaser, the Bank binds itself, its successors, and assigns by these presents.

 - (b) fails or refuses to furnish the Performance Security, in accordance with the Instruction to Bidders;

we undertake to pay to the Purchaser up to the above amount upon receipt of his first written demand, without the Purchaser having to substantiate his demand, provided that in his demand the Purchaser will note that the amount claimed by him is due to him owing to the occurrence of one or any of the three conditions, specifying the occurred condition or conditions.

This Guarantee will remain in force up to and including September 10, 2019 (expiry date) and any demand in respect of this Guarantee must reach the Bank not later than the above date.
