Whereas S.I.T.T.I. S.p.A. with registered office at Via Giosuè Carducci 8 - 20123 Milano - Italy, (hereinafter called the "Supplier") has submitted its offer for 'rft # 381284 : 2 Kalbinių ryšių sistemos pirkimas / Voice Communication System (Pirminiai pasiūlymai / Initial Tenders)' (hereinafter called the "Tender").

At the request of the Supplier, we, Crédit Agricole Cariparma S.p.A. with registered office at via Università 1 - 43121 Parma, Italy (the Bank), unconditionally and irrevocably undertake to pay the Buyer any sum or sums not exceeding in total an amount of EURO 50.000 (EUR Fifty Thousand /00) within 10 (ten) business days since the first written claim, without an obligation to substantiate one's claims, and by merely indicating existence of one or several circumstances listed in Paragraph 8.10 of the SPC in one's letter, by specifying this circumstance or circumstances.

The Buyer shall be entitled to claim payment of the amount specified in the Tender Security Document from the bank, if:

1. the Supplier withdraws the Tender thereof during the effective period of the Tender;
2. the Supplier provided false information in the Tender thereof and the Buyer is able to prove this by any lawful means;
3. the Successful Supplier refuses to conclude the Contract, fails to come at a set time for this purpose, or does not sign it within a set period of time.

If the Suppliers are not successful, the Tender Security shall be returned to them no later than within 20 (twenty) days following the receipt date of the Supplier's request, upon expiry of the Tender. The Tender Security may be returned before the set deadline in the following cases:


1. subject to agreement of the Parties;
2. upon the effective date of the Contract with the Successful Supplier;
3. upon termination of the Procurement procedures.

The Tender Security shall be returned to the Successful Supplier upon signing of the Contract, no later than within 20 (twenty) days following the receipt date of the Successful Supplier's request.

This Tender Security will remain in force up to 31st December 2018 at the latest (the expiry date), and any demand in respect thereof should reach the Bank no later than 31st December 2018, after this date, this tender Security shall be considered automatically and definitely as null and void, irrespective of whether the present original instrument is returned to us or not.
