

LICENSING AGREEMENT

made this 4th Day of February 2026

Between

represented by Head of the Theatre Rasa Bartninkaitė, called the THEATRE of the other part,

Concerning The Play, translated into Lithuanian language by Translator Imelda Vedrickaite - Frukacz

titled "PASAULI, LABAS!" (in original titled *CIEKAWE JAK TO BYŁO*) called "PLAY" , written by Malina Prześluga, called Author.

1. The Licensor hereby warrants undertakes and agrees that he is the sole owner of the copyright for Polish authorised by Author translating of the Play and has the right to enter into this Licensing agreement.
2. The Licensor grants to the Licensee a professional staging rights of the above Play in the THEATRE for to open and further exploitation open since March as follows: 7th, 8th, 10th and 24th and not longer as 30th June 2028 under following terms:
- 3 The Licensee shall pay to the Licensor an advance payment of 500 EUR net (nonreturnable and without deductions) recoupable against future royalties of 8% net of gross box office receipts but not less than 25 EUR net (guaranteed minimum) for each performance. These payments shall be made and sent to the Licensor's agent and representative. The deposit will be made upon signing of this agreement.
4. The Licensor reserves to himself all other Author's rights for radio, film, tape or use other that stated in the aforementioned Articles.
5. The Licensee agrees that on all programmes posters and other advertising matter the name of Author shall appear within a title of the Play.
6. The Licensee shall supply to the Licensor press comments upon such production together with one copy of the programme if available.
7. All money due to the Licensor hereunder shall be sent to the IDEA BANK SA o/ Warszawa

8. This Agreement shall be constructed and carried into effect in accordance with Polish law.
9. Any controversies or claims arising out or relating to this Agreement will be subject to the jurisdiction of the Court of Polish Republic.
10. The Agreement was made in 2 copies, 1 copy therefrom will be retained by the Licensor and 1 copy by the Licensee.
