

**SERVICE PROVIDING AGREEMENT NO.**

*1SUT-6.1}00/A*

This Agreement dated 16 January 2018, Vilnius, between:

**State Enterprise Lithuanian Agricultural and Food Market Regulation Agency**, herein called "**the Customer**", the enterprise code 110073873, VAT identification number LT100738716, residence address L. Stuokos-Gucevičiaus str. 9-12, Vilnius, represented by Acting General Director Artūras Bagotyrius, acting according to the statute of The Customer, and

..., herein called the **Service provider**, personal identification number ..., home address ...

collectively referred to as the "Parties", each of them individually referred to as the "Party", has entered into this service providing agreement, hereinafter referred to as the "Agreement".

### **1. Terms**

The terms used in this Agreement in capital letters shall have the following meanings unless otherwise conferred upon them by the context of the Contract:

1.1. **The Programme** means "Information and promotion programme for the EU meat products in the US and MENA markets", confirmed by European Commission on 12 November 2015 (hereinafter referred to as "the Programme");

1.2. **To conduct a survey** means to survey not less than 200 (two hundred) respondents by spreading questionnaires among professionals/companies in meat industry, such as importers, distributors, retailers, wholesalers, etc. and return 200 (two hundred) filled questionnaires to the Customer by e-mail, transfer personally or in another way (hereinafter referred to as "the Service").

### **2. Subject of the Agreement**

2.1. By this Agreement, the Service provider undertakes to conduct surveys in the target markets of Iran and Algeria as indicated in the Programme, and the Customer undertakes to pay for the provided Services under the terms and conditions stipulated in the Agreement.

2.2. The Customer undertakes to pay for duly rendered Service for the Service provider the price agreed with the Service provider under the stipulations of this contract.

2.3. The Service shall be finished to render by 31 March 2018.

2.4. The Service Provider shall be obligated to render the Service efficiently, in good faith and immediately inform the Customer about any circumstances which impede the Service Provider to render the Service duly;

2.5. The Customer shall be obligated to render all information and/or documentation to the Service Provider, necessary for the supply of the Service. A survey shall be conducted according to the form of the questionnaire which is the Annex of the Agreement.

### **3. Prices and Payment conditions**

3.1. The Customer shall pay for the Service provider 1000,00 EUR (one thousand EUR) for the Service in Algeria Market.

3.2. The service will be charged by bank transfer to the account of Service Provider stated in this Agreement.

3.3. The Services are paid in 10 calendar days after completion by the Service.

#### 4. Cancellation

- 4.1. Agreement can be cancelled only if agreed in writing by both parties.  
4.2. Agreement can be cancelled based on the initiative of one of the contacting parties with 15 days advanced written notice, when one party does not follow obligations of Agreement or follows them in different manners as it is stated in this Agreement.

#### 5. Common rules

- 5.1. All changes and amendments to this Agreement will only be considered as fact if presented in written form and signed by both parties.  
5.2. The Agreement is signed in two copies for each Party having the same legal force.
