

AGREEMENT No. RBS-2017/4

An agreement is made between Customer – **Ukmerges tourism and business information centre**, reg. Nr. **183223352**, at Kestučio a. 2-2, Ukmerge, Lietuva, on behalf of which is it's director - Lina Baubliene and Company **SIA "RBS Baltic"**, reg. code 40103385625, on behalf of which is its Board member Anna Andersone, at Aizpriežu street 9, Riga, LV-1006, Latvia.

1. SERVICES TO BE PROVIDED

In consideration of the mutual agreement contained herein, Customer and Company ("Parties") hereto agree as follows:

Customer hereby engages Company and Company accepts an engagement to provide an organization services for a musical performance of the band "The Swamp Shakers" for the Company's event on September 9, 2017, at the Gyvosios Istorijos Festivalis "Pabaisko mūšis", at the open air stage at Ukmergės r. Pabaisko mstl., at 20.00, in one hour long set, for the amount of fee stated below.

2. FEES AND PAYMENT FOR COMPANY SERVICES

The price for the services states above is 1000 € (One thousand EUR).

Payment will be fulfilled as a bank transfer in EUR currency unless other arrangements are made prior to performance. Customer will transfer 100% of the Contract fee value according to the invoice of the Company to the bank account designated by the Company within terms mentioned in the invoice.

3. MISCELLANEOUS

Customer will provide Company with a 24 hour phone number where Customer may be reached in case of an emergency.

This Agreement may be terminated by the mutual consent of the parties hereto, but no later than 14 (fourteen) days prior to engagement.

4. FORCE MAJEURE

Neither of the contractual Parties shall be liable for not fulfilling the obligations hereunder as a result of natural disasters, war, government interference, serious sickness, accident, means of transportation, Act of God, fire, riot, strike or other events unforeseeable, unavoidable and insuperable by the Parties. The party invoking a Force Majeure shall notify the other party within three (3) business days of its occurrence by accurately describing all the circumstances of the situation involved and its effect upon the performance of its contractual obligations. The

Parties shall provide within 7 days the valid documentary evidence issued by the notary department of the place where the force majeure event occurs.

5. SETTLEMENT OF DISPUTES

All disputes arising from this Contract shall be settled through consultation by both Parties. In case no settlement can be reached through consultation, the Parties may file the dispute to the Latvian Republic court.
