

**SPEAKER/PRESENTOR AGREEMENT FOR  
TRAINING SESSION FOR KAUNAS HOSPITALITY COMPANIES**

This agreement is made and entered into at this date, by and between public Institution "Kaunas IN" and THE Invited Speaker: Linda Pereira (company CPL Events)

SPEAKER agrees to prepare and present the following program(s) at EVENT at Kaunas destination, Lithuania.

TO ADAPT: Wednesday, 10:00 "Training session for Kaunas hospitality companies" (The event will take 3 - 4 hours)

Expenses and Other Financial Considerations:

"Kaunas IN" will supply SPEAKER with a round trip ticket, economy comfort class . The desired date of travel is to be notified before September 5, 2019. The flight tickets will be sent to the speaker at least 3 weeks prior to the flight.

COMPANY

COMPANY will reimburse SPEAKER normal and customary ground transportation.

COMPANY will provide SPEAKER with the cost of meals up to a maximum of € 50 (fifty euro) per day based on submitted receipts.

Any expense items not specified above are expressly excluded from reimbursement.

No presentation or materials produced by the SPEAKER will be produced, taped, recorded, streamed or distributed without express permission from the SPEAKER.

The SPEAKER hereby warrants and declares that the Presentation, handouts, and related materials are factually accurate and contain no matter libelous or otherwise unlawful. The SPEAKER further warrants that such Presentation, handouts, and related materials are either the SPEAKER's own original work or presented with the permission of the originator/owner of the material.

The SPEAKER understands that permissions granted to COMPANY under this agreement do not prohibit the SPEAKER from using the Presentation including handouts or other materials utilized in the Presentation for COMPANY in the future in the SPEAKER's professional or personal work.

The SPEAKER authorizes the COMPANY to use his/her name, likeness, photograph, and biographical data in connection with the use and promotion of any aspect of the Presentation including rebroadcast on a "virtual" basis.

This agreement is binding on both parties and cannot be cancelled except as hereinafter provided. COMPANY and the SPEAKER mutually agree that all parties

shall be released from any and all liability or damages hereunder if COMPANY or the SPEAKER is unable to fulfill the terms of this agreement due to: an act of God, illness or physical disability of the SPEAKER, acts or regulations of public authorities, labor difficulties, civil tumult, strike, epidemic, flood, fire, interruption or delay of transportation, or any other cause beyond the control of the parties.

If, for any reason, the SPEAKER is delayed or cannot appear, the SPEAKER will promptly notify COMPANY to arrange a mutually agreeable change of date and/or a substitute SPEAKER. Any benefits, deposits, and/or advance reimbursements under this agreement shall be transferred to the substitute SPEAKER, if any. If a change of date or substitute SPEAKER cannot be mutually agreed upon COMPANY and the SPEAKER agree that this Agreement is cancelled and that the SPEAKER shall refund any deposits and/or advance reimbursements that have been received from COMPANY.

The COMPANY pays the amount of 2000 Eur fee for the SPEAKER COMPANY. The fee will be divided 50 percent deposit before the training session and 50 percent – after the session (the invoices will be sent to the COMPANY). In case of the SPEAKERS cancelation – the deposit (1000 Eur will be refunded to the COMPANY).
