Wash solution for sample probes on Roche/Hitachi **cobas c** systems.

### Summary

Sample probe washes may be required due to potential interference from other samples. These special washes maintain sample integrity.

### Reagents - working solutions

Sodium hydroxide solution 1 mol/L
