1. OBJECT:

1.1. This agreement is made for the dance seminar, which will take place on the 26th – 30th of August, 2019, and is described herein:

Number of sessions	5 (five)
Length of sessions	4 hours
Place of seminar:	Culture Factory, Klaipėda, Lithuania

2. FINANCIAL DETAILS:

2.1. For the Object of this agreement, the ORGANIZER will pay the WORKSHOP LEADER the expenses mentioned below:

- **Fee – 500,00 €** (to hands). The fee will be paid after signing the agreement and transfer-acceptance act of provided services after the seminar is finished. The taxes above amount of fee will be paid by the ORGANIZER;
- **Travel expenses – flight tickets** from Brussels to Palanga on the 24th of August;
- **Accommodation** for 1 person for 6 nights (single room). Provide Lodging in the city center.

3. THE ORGANIZER AGREES THAT IT WILL:

- 3.1.** Provide the space for seminar, together with required technical equipment;
- 3.2.** Provide publicity and do all in its power to inform the professional public about the seminar, and organize registration to the seminar;
- 3.3.** Guarantees to provide WORKSHOP LEADER with all information or documents necessary for the service rendering;

3.4. Pay the WORKSHOP LEADER following the settlement order and deadlines for good quality and duly provided services in accordance with the terms and conditions of this Contract.

4. THE WORKSHOP LEADER AGREES THAT HE WILL:

- 4.1. Provide the ORGANIZER with a list of technical requirements;
- 4.2. Provide the ORGANIZER with contents and images to be used in the promotion materials. The ORGANIZER has the right to use the images in future and historical presentations of the seminar and company's activities;
- 4.3. Make every effort to participate in such press, radio or TV interviews, photo calls or publicity appearances as the ORGANIZER may reasonably arrange. Subject to reasonable prior notice, and in accordance with its agenda;
- 4.4. Fulfil the seminar strictly according the schedule agreed by the Parties.

5. MISCELLANEOUS:

- 5.1. In all cases the ORGANIZER shall make a reference to the name of the WORKSHOP LEADER;
- 5.2. Photography and any taping of the WORKSHOP LEADER's seminar (by video, film, radio, TV, sound and/or recording systems) is allowed only to the official company's photographs and video operators, and only if there is a consent of the WORKSHOP LEADER;
- 5.3. The ORGANIZER grants to send the WORKSHOP LEADER a compilation of promotion materials and press clippings concerning the seminar;
- 5.4. The ORGANIZER and the WORKSHOP LEADER grant to use every resource in order to let the seminar take place without any disturbance.

6. LEGAL ISSUES:

- 6.1. The losses caused by non-fulfilment of the obligations assumed under this Agreement or inadequate fulfilment shall be compensated by the party in default.
- 6.2. The Force Majeure notion, rights and responsibilities of the Parties on these circumstances are described and regulated by the Article 6.212 of the Civil Code of the Republic of Lithuania.
- 6.3. All disputes rising out of non-fulfilment or improper fulfilment of the Contract provisions shall be solved by mutual negotiations. Should the disputes be not solved by negotiations, they shall be settled by the court following the laws of the Republic of Lithuania.
- 6.4. This agreement may not be changed, modified or altered except by an Instrument in writing by the parties.
- 6.5. This contract has been issued in two (2) identical copies. All copies are to be signed by the ORGANIZER and the WORKSHOP LEADER.
