SERVICE AGREEMENT

1. Subjects of the Agreement

Public Institution Diversity Development Group (*VšĮ Diversity Development Group*), an institution established and operating in accordance with the laws of the Republic of Lithuania, legal entity code 302877111, registered address Lukiškių g. 5-527, Vilnius, data about the company are collected and stored in the Register of Legal Entities of the Republic of Lithuania, represented by the Director Karolis Žibas, acting under articles of association of the organisation (hereinafter – the Customer) and Rugilė Butkevičiūtė, registered address [REDACTED], Lithuania (hereinafter – the Executer).

2. Object of the Agreement

The Executer shall undertake RESEARCH SERVICE (hereinafter – the Service) in the international project “Children First: Addressing Gender Based Violence from the bottom-up”, Grant Agreement No. 856844, REC-AG-2018/REC-RDAP-GBV-AG-2018, under the terms and conditions established in the Agreement, and the Customer shall undertake to pay to the Executer for properly provided Services under the procedure provided for in this Agreement.

3. Service Description, Terms and Prices

Part of WP2:

Activity 2.2 Capturing the views of children and young people on gender-based violence occurring in teen relationships.

Primary research (40 days): Youth led Focus group (12-15 children), 10 Interviews with children & young people, 100 online questionnaires, National Report.

To pay for these WP2 Services the amount of 6400 EUR

Part of WP3:

Activity 3.1 Mapping existing strategies and policies related to school gender-based violence and abuse.

Primary and Secondary research (22 days): 10 Interviews with teachers, 10 Interviews with parents, 5 Interviews with institutions, 50 online questionnaires, National Report.

To pay for these WP3 Services the amount of 3520 EUR.

To pay for these WP2 and WP3 Services the total amount of **9920 EUR.**

4. Obligations of the Parties

4.1. The Executor shall undertake to provide Services specified by the Customer within agreed time limits – by 2021-08-30 (the end of the project).

4.1.1. The Executor shall undertake to provide Services in high-quality and timely manner in compliance with coordinated requirements.

4.1.2. The Executor shall undertake not to reveal confidential information to third parties about the Customer and its services or information that could have become available to the Executor while performing works or otherwise or at any other time.

5. Service Price and Settlement Procedure

5.1. The Service price is specified in Item 3 of this Agreement. The Executor is not subject to VAT; therefore, VAT shall not be calculated.

5.2. The payment shall be made in 14 business days following proper performance of Services and signature of service transfer and acceptance act (optional).

6. Liability

6.1. Where the Customer fails to pay the remuneration specified in the Agreement, the Customer shall pay to the Executor the interest of 0.2% from outstanding amount for each day overdue.

6.2. Where the Executor fails to provide Services within time limits determined in the Agreement or according to the schedule coordinated by the parties, the Executor shall pay to the Customer the interest of 0.2% from outstanding amount of this Agreement for each day overdue.

7. Other Conditions

7.1. If either of the conditions of the Agreement is treated as invalid, the Agreement shall not become void because of this. In such case, invalid conditions shall be replaced with a condition which in terms of its substance is the closest.

7.2. The Agreement shall be subject to the laws of the Republic of Lithuania; the Agreement shall be valid in the territory of the Republic of Lithuania.

7.3. Disputes of the parties shall be negotiated. In case of failure to negotiate, disputes shall be settled in the courts of the Republic of Lithuania.

7.4. The Agreement shall be valid till full performance of obligations of the parties.

7.5. The Agreement is concluded in two copies having equal legal power.
