PROFESSIONAL SERVICES AGREEMENT
For INSTITUTE FOR STRATEGIC MANAGEMENT teaching service at Kauno
kolegija / Kaunas UAS

This Agreement is made by and between the INSTITUTE FOR STRATEGIC MANAGEMENT, ESTONIA (hereinafter referred to as ISMAN) and Kauno Kolegija / University of Applied Sciences, Lithuania (hereinafter referred to as KK)

WHEREAS, KK is desirous of obtaining the services of Ivar Soone from ISMAN, to teach Marketing Management course at KK during the autumn semester(s) of the 2020/2021 school year (totally 10 working days, 20 teaching hours) in accordance to the Agreement:

WHEREAS, ISMAN is willing to provide Teaching service.

NOW, THEREFORE, in consideration of the mutual promises contained herein, and for other good and valuable consideration the receipt and adequacy of which are hereby acknowledged, the ISMAN and KK agree as follows:

1. During the autumn semester of the 2020/2021 school year but not later than 31 October, 2020, the ISMAN will provide to KK the services of Marketing Management course as are to be determined by and between **ISMAN** and the Faculty of Business of KK.
2. For providing such services, KK will pay to the **ISMAN** the total sum of 2800, -EUR to be allocated by the **ISMAN** as follow teaching service.
3. The payment referred to in paragraph 2 above is due and payable on or before 20 November, 2020. The payment is to be made payable to the ISMAN and sent to: EE707700771000417362, AS LHV Pank, Tartu mnt 2, 10145 Tallinn, BIC/SWIFT: LHVBE22, bank code: 689, Commercial Register Code: 10539549.
4. It is understood that ISMAN will continue salary and fringe benefits during the period described in paragraph 1 above, and his/her employment status with the ISMAN during such period will be that of an employee on a paid leave of absence.

5. Provided teaching service cannot assign any rights or obligations under this Agreement without the prior permission of the ISMAN.

6. No waiver by any party to this Agreement of any default or non-performance shall be considered a waiver of any subsequent default or non-performance. If any provision in this Agreement is unenforceable, that shall not impair enforcement of other provisions.

7. Any changes to this Agreement must be agreed upon in advance by both parties in writing.

8. This Agreement shall be interpreted and construed under the laws of the Republic of Lithuania and the policies and procedures of the involved institutions, as amended from time to time.
